## **General Liability for World School Programs**

**Assumption of Risk.** You, as parent and/or guardian of your child(ren) are aware of the inherent risks of injury, death, and property damage involved in World School, Inc. activities including but not limited to climbing, swimming, backpacking, mountain biking, elephant riding, kayaking, including without limitation risks due to drowning, near drowning, falls, etc. You as parent and/or guardian of your child(ren) are aware of the risks of injury, death, and property damage that may result from, among other causes, the act of active and passive negligence of World School, Inc. and its sister corporations, all officers, directors, shareholders, employees, agents, representatives, successors, assigns, and heirs (collectively, "related parties"), including without limitation the risk of negligent instruction or supervision. You as parent and/or guardian have voluntarily allowed your child(ren) to engage in activities including but not limited to climbing, swimming, backpacking, mountain biking, elephant riding, kayaking, , etc., with knowledge of the risks of injury, death, property damage, and other risks, and assume any and all known and unknown risks of injury, death, and property damage that may result from World School, Inc. activities including but not limited climbing, swimming, diving, backpacking, mountain biking, elephant riding, kayaking, etc.

**Release of liability.** You as parent and/or guardian of the child(ren) hereby release the related parties from all liability to you as parent or guardian, and or child(ren), principals, employees, agents, representatives, guardians, successors, assigns, heirs, and next of kin for all liability, claims, damage, or demands from personal injury, death, or property damage, arising from or related to this agreement or to World School, Inc. activities including but not limited to climbing, swimming, backpacking, mountain biking, elephant riding, kayaking, , etc., whether the injury, death or property damage occurs on or off the premises. This release includes, without limitation, any personal injury, death, or property damage caused by the active or passive negligence of any of the released parties. You as the parent and/or guardian of the child(ren) bear sole responsibility for any loss.

**Hold Harmless.** You as parent and/or guardian shall indemnify, defend, and hold harmless World School, Inc. and its partner corporations, all officers, directors, shareholders, employees, agents, representatives, successors, assigns, and heirs (collectively, "indemnitee"), against all liability, demands, claims, costs, losses, damages, recoveries, settlements, and expenses (including interest, penalties, attorney's fees, expert witness fees, costs, and expenses) incurred by indemnitee ("losses"), known or unknown, contingent or otherwise, directly or indirectly arising from or related to your child(ren)'s participation in World School, Inc. activities.

negligence and a release of their liability. You as parent and/or guardian of the child(ren) acknowledge that World School, Inc. is materially relying on this waiver and is allowing your child(ren) to engage in activities including but not limited to climbing, swimming, backpacking, mountain biking, elephant riding, kayaking, etc.

No refund or adjustment is made, and no prior notice is made, if World School, Inc., changes its program by adding, altering, or deleting activities as deemed necessary by the directors. World School, Inc., cannot accept responsibility for any personal item lost or damaged by fire, theft. World School, Inc., may use any pictures or videos taken of students during World School, Inc. time. This includes digital images which may be posted on our web site.
